MEETING MINUTES

CALL TO ORDER: The meeting was called to order at the MCL Cafeteria at 7:01 p.m. on January 10, 2019, by the Club President, Scott McGaha.

ANNOUNCEMENTS:

Scott opened the meeting with a welcome back for the New Year with hopes that all had a wonderful holiday. He briefly highlighted the activities at our annual Christmas dinner and the fun that was had by all. Scott then gave a month by month outline of the activities the club was involved in during 2018 which included: (1) January: Green's Part Sales, (2) February: Jungle Jim's, (3) March: Richardson Car Collection, (4) April: Dayton Art Institute with lunch at Brixx, (5) May: Air Force Museum for Thunderbird Appreciation Day, (6) June: Butler County Donut Run, (7) July: Dinner at the Houston Inn, (8) August: Rip Rap Roadhouse Cruise-in and Dinner, (9) September: Club Picnic, (10) October: no event, (11) November: Valley Vineyards, and (12) December: Club Christmas Dinner. He also mentioned several of the projects we had taken on such as establishing a club Facebook page and the creation of the Sunshine Committee to recognize member birthdays and anniversaries by sending them cards.

Scott announced that he was deferring the approval of the November 2018 meeting minutes until the end of this club meeting to allow folks time to read copies he had distributed. He then proceeded by questioning if there were any new prospective club members. None were identified.

Scott distributed the latest copy of the club membership roster and requested that everyone check their information and make corrections as necessary. Once all members had reviewed their information the sheet was to be returned to Brett for updating.

Finally Scott asked if any one had purchased a new thunderbird or had any ongoing work on their T-birds. No inputs were received.

Because there was no formal club meeting in December, Scott recognized the December and January birthdays for Darrel, Lisa, Beverly K, Julie, Dave, Brett, & Roger and the 63rd anniversary of Guy & Jan.

REPORTS:

Treasurer's Report: With our club treasurer unavailable, Roger was unable to provide a numerical financial report but did state that Lisa confirmed there had been no change in the club's bank financial status since the last report in November 2018. Scott asked Roger to remind Lisa that in accordance with the club bylaws that an Annual Summary Financial Report is due.

Event Planning:

The discussion moved on to the planning of club activities. Scott's distributed agenda contained a series of suggestions and additional suggestions were made from the floor. For January it was recommended that due to potential winter weather impacts we do something simple. After some discussion it was agreed that on January 19th members would take in a movie of their choice at the Greene and then meet afterwards at the Pies and Pints Restaurant at 2:00 pm for lunch. Because the weather forecast for that date did not look promising, Scott indicated that he would send out an e-mail prior to the event to confirm or cancel depending on the forecast.

It was also tentatively decided that for February we'd made a trip to the Mound Cold War Discovery Center in Miamisburg on the 16th. Plans for this February event will be finalized at the club meeting on the 14th along with discussions about events for later months.

OLD BUSINESS:

Scott announced TSWO club dues were due and that Roger would collect dues from any who wanted to pay this evening and he would give it to the treasurer.

Scott re-emphasized the need to made a decision as to whether the club wants to have an overnighter in Kentucky and if yes whether in April or October. If the choice is April that decision must be made by February if the trip is to include going to the horse races at Keeneland. Discussions will continue at the February meeting.

Finally Scott addressed the issue of the sale of the club audio equipment. Although there had been one confirmed and a few possible takers, it was ultimately determined that only the Troy Junior High School Student Activity Council continued to show interest in the equipment. Scott reminded folks that the club bylaws dictate that the final decision for the purchase, donation or sale of club equipment is the sole responsibility of the Board of Directors. However, the bylaws as strongly encourage discussion and recommendations from the membership. As such, Scott brought the question to the floor noting that Troy was the only party interested in purchasing the equipment for \$150. When the question was put to the membership, they were in agreement that Troy Junior High was a worthy organization and thus support the sale. Hearing no objections from the floor, Scott noted that the BOD would meet to finalize the sale.

January Club Outing: Movie & A Pizza



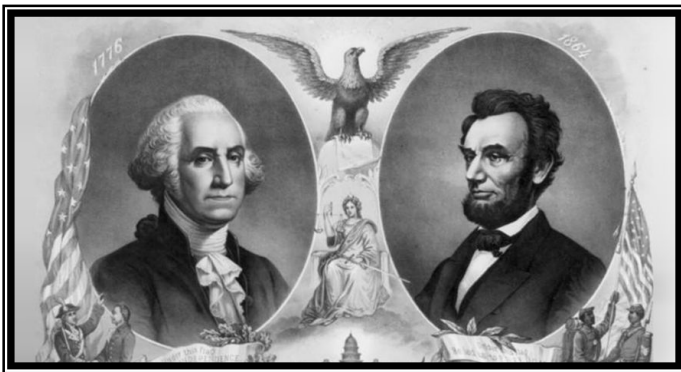

Short History of Presidents Day

Most folks know that Valentines Day is in February and probably even know the exact date, but how many know the when or why of Presidents Day. It must be a relatively significant day since many folks get the day off. I can't say the same for Valentines Day. In fact, I spent way more money and time involved in the expectations of the Valentines Day mystique that I do on Presidents Day. So let's learn a little about Presidents Day.

Presidents Day is a holiday celebrated every year on the third Monday in February. It's a day to honor all of our great nation's presidents, but it started out as a celebration of one president in particular. Presidents Day was originally a celebration of our first president, George Washington. In fact, the federal government still calls it "Washington's Birthday" officially. Washington died in 1799, so come 1800, people wanted a day of remembrance on his birthday, February 22. Throughout most of the 1800s the observance was more casual, but by the late 1870s the U.S. government wanted to make it an official holiday. In 1879, Congress made Washington's Birthday a day off for government offices in the District of Columbia, then expanded it to all federal offices in 1885. It was nationally recognized as a federal bank holiday, joining the ranks with Christmas Day, New Year's Day, Independence Day, and Thanksgiving. Washington's Birthday is the first holiday to celebrate an individual American—the second was Martin Luther King Jr. in 1983.



In the 1960s, Congress came up with the Uniform Monday Holiday Act, which basically would shift certain holidays to predetermined Mondays so people would get more three-day weekends every year. The idea was that it would give workers more time off so they wouldn't play hooky as often, but some thought it would cheapen the holidays by not celebrating them on the actual day. The act also combined the celebration of George Washington's birthday with Abraham Lincoln's, which was on February 12. Senator Robert McClory of

Illinois—where Lincoln's Birthday was already a state holiday—suggested we rename the holiday "Presidents Day," but was met with resistance. The name didn't change officially, but the rest of the act was passed and went into effect after an executive order from President Richard Nixon in 1971.

Still, somehow the name Presidents Day stuck around because the new date of Washington's Birthday fell between his and Lincoln's birthday. Retailers and advertisers latched onto the catchall moniker, using it for deals and sales during the long weekend, and by the 1980s most Americans knew the holiday as Presidents Day. Over the last 15 years or so, even official state calendars have started listing the holiday as Presidents Day. Now the holiday is considered a time to celebrate and honor all U.S. Presidents past and present.
